New Boating Regulations

The new boating regulations regarding operator licencing and safety equipment has been passed into law and do show some considerable changes from their first inception. They have publicised the regulations and included with this newsletter is the O.P.P. Marine Safety Awareness Handbook which goes into the regulations in detail.

These few points are particularly important.

- If you are less than sixteen years old, operating a Personal Water Craft is illegal for you.
- Floating seat cushions are no longer considered an approved Life Saving Device.
- A "Floating Heaving Line" that is at least 15 metres in length is mandatary equipment on almost every type of water craft.

 Operating a powerboat with an engine that does not have noise muffling equipment in use within five miles of any shore is illegal.

A more thorough listing of all of the pertinent regulations is published in the "SAFE BOATING GUIDE" by Fisheries and Oceans, Canada, and The Canadian Coast Guard.



Make Your Own Heaving Line

The new Coast Guard regulations require a buoyant heaving line of not less than 15 metres in length as safety equipment for most boats. Both powered and non-powered boats require this line. Only a very few commercially available heaving lines can be found and most of the prices that we can find were exceedingly expensive. Making your own is, however, very easy.

It will first be necessary to make a knot called a MONKEY'S FIST. A ¼ inch floating line (either braided or twisted) can be used. To add weight, we insert a small stone or nut or other weight into the knot before we tighten it. Start with about thirty or forty inches of line and do not try to tie your knot too tightly until it is formed. Then we can tighten it to be quite hard. Good Luck.

Bacterial Water Testing 1999

During the 1999 summer season, four different series of testings will be done. Two will be completed in July and two in August. Each test will comprise five samples and the test criteria will be an examination of these samples for faecal coliform bacteria and for total bacteria by a private lab in Ottawa.

The sites tested will the main dock in Charleston Village, the beach at Sand Bay (Counties Park) and the pool just above the outlet dam. The other two locations at each test may be moved from test to test. These moveable sites will be used to investigate areas where our members have suggested their suspicions of a pollution problem.

None of the tests last season suggested any need for concern. Contacting the office of the Medical Officer of Health to report any findings was not necessary. Some tests were done immediately after heavy rainfall and did show some trace of bacterial contamination due to run off. No tests, however, were sufficiently high to justify further action.

In 1999 I will again need volunteers to help with the water testing. If you are able to help please telephone me at 613-345-2866.

Water Levels - Questions and Answers

Was the water higher this year? No. For several years in the recent past the water has been as high or higher.

Why was there so much damage to docks and boathouses this year? Several factors contributed to the damage this year. The meltdown and fill under the ice before breakup was very rapid. The ice went out accompanied by a severe wind from the north that yeered to the east.

Did the Outlet Dam play any part in the damage? Before we can discuss the effect of the dam we have to understand all that the Dam does and what the Dam cannot and does not do. The Dam helps to maintain the water level at a level that is best suited to most users and protects the spawning beds from freezing and from drying out. Charleston is a lake with a granite and limestone bottom. It is very much like a basin in that there is only one outlet. Natural factors such as drought or heavy rains play a far more significant role in the water levels than does the Dam. Last year the water was very high through the third week in July. This year, because of the lack of rain, the level is perhaps three inches lower than normal at this time of year (mid May).

What would happen if there were no dam? This would affect the lake levels severely. We would still have extremely high water in the spring. We would have very low levels much earlier in the summer.

Why would there continue to be high water levels even if there were no dam? During the last twenty to thirty years each year has brought high water levels. A large swamp or bog on Wiltse Creek causes this. This swamp is between the Outlet and the Marble Rock dams. This swamp has grown every year and continues to grow. It causes a water back up of such size that sometimes the water in the creek runs backwards over the dam into the lake. During the run off this year, all of the logs were out of the dam. Effectively, this means there was no dam. The water was as high on one side of the dam as it was on the other.



Can anything be done about this swamp? Yes. We could channel and deepen the swamp to provide a greater outflow for the water. This operation would be very expensive. Some years ago the progenitor of the Granite Power Corporation in Gananoque had estimated that the cost would have been no more than \$20,000. They offered to pay 25% of this cost. They suggested that the remaining portion of the cost be born by our governments. Today the cost would be well more than \$100,000. This is only for the physical engineering work and does not take into account any environmental study costs or legal fees that we would require today. No doubt there would be considerable vocal opposition to any plan and the cost could conceivably run to well more than \$1,000,000.

What can we do to resolve the problem? We should continue to encourage and lobby with all levels of government, and the Granite Power Corporation, to seek some practical solution to resolve the problem. We should recognise the reality of the problem and the difficulty in finding any solution. We should encourage anyone contemplating building or replacing any docks or boathouses to consider the floating alternative to fixed structures.

Who is ultimately responsible for water levels on Charleston? The responsibility rests with the Provincial Government and their Departments and Agencies.

Waterfront Improvements

A permit is required for construction work on Charleston Lake's waterfront. This includes additions or changes to existing structures.

The permit is designed to promote a healthy lake eco-system by ensuring the use of proper, ecologically sound practices for work on the waterfront. Please do not carry out work without a permit.

Failure to comply with the various rules and regulations could result in a maximum \$5,000. fine for each offense. In addition, the courts may order you to restore the site to its original condition at your cost.
