

Charleston Lake Water Test Results

Over the past summer Ontario Lake Assessments, were contracted to your Association to conduct a series of studies and test of the water of Charleston Lake. This contract was financed by a grant from the Charleston Lake Environmental Association (a charitable trust foundation) as a part of their on-going program to protect and advance the natural beauty of Charleston Lake.

Tests were completed from the surface to the bottom for oxygen, temperature, pH, conductivity and salinity at six different sites in the deep water portions of the Lake. In addition phosphorous samples were collected at these six sites. This resulted in the collection of approximately six thousand five hundred readings or analytical results. All of the survey results will be presented in a report prepared

coliform, Faecal streptococci and Escherichia coliform or 'E Coli' were done.



None of the tests showed results which approached any level of major concern, but several things were made apparent by our testing. All measured levels were higher at the creek outlets than in the Lake itself at the points chosen for measurement. The presence of elevated numbers of Faecal streptococci in these readings is indicative of contributions from

E Coli may be present in the water of Charleston Lake and was apparent on several tests. There are many different strains of E Coli, all of which can cause illness; some strains can be fatal if ingested. All lakes, regardless of how pristine, are surface water and as such should not be considered potable without appropriate treatment. We recommend a hearty boiling before consumption. We recognize that many people drink the water directly from the Lake without treatment and have done so for years with no apparent problem. We cannot recommend or endorse this dangerous practice. No sickness is more the result of good luck than good management.

We are pleased with the results of testing to date and can only repeat what we have said before: COME ON IN, THE WATER'S FINE.

by Ontario Lake Assessments to the Charleston Lake Association early in the new year.

These tests were made at nine Lake sites each time and four additional sites were tested at creek mouths feeding to the Lake. Expected is that the M.N.R. will use the information as a base for a Trout Management Plan geared to ensuring that Charleston Lake enjoys a natural self-sustaining lake trout population in future years.

Meetings held with the Ontario Provincial Police (O.P.P.) this past winter resulted in a substantial increase in the number of patrols on the lake this summer. Our thanks to Sgt. Larry Fitzpatrick and members of his detachment for a job well done.

Notice of proposed Constitution change

Proposed Change to the Constitution and By Laws of the Charleston Lake Association.

Notice: At the next Annual General Meeting of the Charleston Lake Association, the Directors of the Association will place before the members, and recommend the adoption of the following change to the Constitution and By Laws of the Association.

The reason for this recommended change is to make what has, for many years, been the accepted practice of the Association comply with the relevant By law without the necessary requirement of a special motion enacted each year.

This proposal, which will be moved by the President and seconded by the Directors as a whole would serve to remove the entire paragraph 4.01 from Article 4 of By law 1. and replace it with the following words:

A4.01 Officers. - The officers of the Association will consist of a president, one or more vice-presidents, a secretary and a treasurer. "These officers will be elected by the directors at the first meeting of directors after the annual general meeting at which these persons were confirmed elected as directors."

The paragraph which would be deleted now reads:

A4.01 Officers - The officers of the Association will consist of a president, one or more vice-presidents, a secretary and a treasurer, all of whom shall be elected by the members at the annual meeting of members from among the persons elected at such meetings as directors.

Environmental Association's agenda

On the top of our agenda is the total Water Quality Assessment project that has been underway all summer.

Ontario Lake Assessments is in the recording, graphing and analysis stage and expects to deliver their final report to us by late Fall. An interim report is shown on page 1.

A similar assessment of the lake was done in the early 80's by the Ministry of Natural Resources (MNR). We are working with the MNR and Ontario Lake Assessments to retrieve that report.

From the two studies we would have a good measure of the changes over that time period and good benchmarks for future comparisons.

After a full review and discussion of the results, we will make a full report to the membership. We expect this project will lead to a number of measures we can all follow to enhance the overall water quality.

We are nearing the completion of a brochure which outlines the mission, objectives and numerous details of this Charitable Foundation. It should be ready for the printer soon and we hope to have a copy in your hands by year-end. It also explains a number of ways you can support this very important endeavour.

Annual General Meeting report

The Annual General Meeting was July 8th and was held in the Holy Trinity Anglican Church Hall on the Lower Oak Leaf Road.

Visitors attending and welcomed to the meeting were members of the Friends of the Charleston Lake Park Organization, Henry Garcia from the Leeds and Grenville Health Unit, and Marilyn Tedford, President of the Bass Lake Association.

Guest speakers were Gary Nielsen of the Leeds County Stewardship Council and Doug Hale, President of the newly formed Charleston Lake Environmental Association.

Gary outlined the mandate and various programs of the Stewardship Council. He provided a number of examples of the good things that can happen to the environment when his organization, landowners and volunteers work together as a team. Gary concluded his remarks by describing the uniqueness of Charleston Lake and the lands within a 100-mile radius of the lake. "Our rock formations, certain trees, reptiles, wildflowers and wildlife species are not found elsewhere in the Province of Ontario.'

Doug Hale provided information on the newly formed Charleston Lake Environment Association. This new organization is dedicated to 'leaving no stone unturned' in protecting/enhancing the environment of Charleston Lake. All members of the Charleston Lake Association, stated Doug, are encouraged to contribute to the Environmental Association; receipts will be provided for income tax purposes. Water Quality is a top priority and therefore

the Environment Association has donated over \$10,000 to the Charleston Lake Association to carry out the major



water quality-testing program underway on the lake this summer. Directors of the Charleston Lake Environmental Association are Doug Hale, Ron Webster, John Brownlie, Borden Purcell and Hugh Segal. Doug advised that additional information regarding his group would be provided along with Charleston Lake Association Newsletters or in separate mail outs.

Secretary-Treasurer Judy Wyatt reported that the Charleston Lake Association is in excellent financial shape with revenues exceeding expenditures and funding in place for all current programs.

AROUND THE LAKE

Thank-you for asking

Q. What is causing the increased weed growth and incidents of Nuisance Algae?

A. Aquatic weeds and algae, like other natural populations, fluctuate from year to year. In 1978, a Charleston Lake landowner wrote in his diary, 'In shallow bays the aquatic growth was amazing. By mid-summer it would choke the water and then die off in the icy winter'. We can speculate that this year's heavy rains and increased run-offs are causing greater levels of phosphorus in the lake and therefore greater weed growth. Our water sampling program being carried out by Ontario Lake Assessments is testing for phosphorus, calcium, dissolved oxygen, etc. The results of these tests will be available by the end of the year and published in our Winter 2001 newsletter.

Q. What can be done about these Professional Bass Tournaments with high-powered boats?

A. Across Canada and the U.S.A. competitive fishing is increasing and is considered a popular and legitimate activity. We have met with the Ministry of Natural Resources (M.N.R.) in regards to the increasing number of tournaments on Charleston Lake. The M.N.R.'s current policy states that they will remain neutral in relation to fishing tournaments. They recommend that Lake Associations work as a team with tournament organizers to resolve problems. In March 2000, the Charleston Lake Association issued and distributed to organizers a set of guidelines for tournament fishing on Charleston Lake; the organizers in turn provided each of their members with a copy of the guidelines. The introduction to the guidelines state:

The Association will support competitive fishing events where: -

Fish and other aquatic resources are protected and the fishing effort does not exceed

the capabilities of the resource, to sustain desirable fish populations.

- Tournament organizers and participants take into consideration the needs of all lake users and extend to them courtesy and cooperation.
- When fishing on Charleston Lake, tournament organizers incorporate these guidelines into their official tournament rules.

To obtain a copy of the guidelines, please write to the Charleston Lake Association, P.O. Box 609, Athens, Ontario, K0E 1B0, Attention: Fish and Wildlife Committee. We will continue to review the fishing tournament situation with the M.N.R. and problem areas with the tournament organizers. Currently we are working with tournament organizers to ensure an equitable distribution of bass upon
