Charleston loses popular businessman

Although he long ago admitted that hard work, Lake Line Lodge, and hunting and fishing consumed his life, Glenn Ireland is best remembered as a man who above all, cared for family, friends, and his community. There was never a maybe, Glenn gave his all, all the time.

He died on Sunday, January 16th at the age of 73. Family and friends, some from the US, packed Judson's Funeral home in Athens for Glenn's Funeral.

Glenn started Lake Line Lodge in 1962, while employed at Automatic Electric in Brockville for 25 years. In 1970, the family moved to Charleston, and Glenn devoted full time to the business. It started with 5 cottages, and grew to 8, and added a full service marina in 1994, the same time that Glenn retired and turned the business over to Shawn and Irene. He was, however, always available to lend a helping hand whenever needed.

Glenn loved the lake, and took great pride in showing it to guests from his pontoon boat. Many of the original guests are still coming to Lake Line Lodge for their vacation.

Glenn excelled at everything he ever did. Glenn also smiled a lot. He was a happy man who was fond of children, enjoyed work and took the time for pleasure,

As a businessman, he taught his staff the value of hard work to achieve success; a lesson that many of the former staff took with them to their rewarding and prosperous careers. He was never too busy to take time out of his work day to share a story about Charleston Lake, or one of his life experiences.

As an outdoorsman, he enjoyed hunting, fishing and travel. His travels took him in every direction, as far as Hawaii and Alaska, to Myrtle Beach and Florida, and in Canada from east to west.

The game of golf might have been the one pursuit to give Glenn trouble. One time, while golfing in Myrtle Beach, a red fox, shaking its head, came out of

the woods and walked right up to Glenn and gave him a golf lesson.

Heaven will be especially welcomed by Glenn, because he will find a lake as beautiful as Charleston and a golf course where he can break 80.

There was little Glenn did not do for the Charleston Lake Association. He took particular interest in preserving the lake trout population and over the years assisted the MNR in stocking the lake with trout.

A look back in time...

The 'Grand Old Man' of Charleston Lake

Charleston Lake's Grand Old Man was the late Joseph (Joe) Kelsey, who was born in Charleston Village and lived there for 91 years.

Joe's father, William Kelsey, was the first white man to settle at Charleston. He came from the Mohawk valley in New York State and actually hewed his way into the settlement on the side of Charleston Lake, which was originally populated by the Mohawk Indians.

Joe was born in the white house down by the lake on April 27, 1871. In 1881, then a lad of 10 years old, Joe began working as fishing guide and continued throughout his lifetime to guide generations of fishermen over his favourite Charleston Lake.


In addition to being a well-known guide, Joe Kelsey also was a boat builder, owning the Kelsey Boat Livery for which he built all the boats. Originally he built rowboats for the livery but later turned his hand to making square-sterned boats for outboard motors.

In the summer of 1961, at 90 years of age, Joe continued to enjoy the lake, taking frequent trips on the water in his own boats. His family repeatedly warned him about going out alone but he still slipped away in his 3-hp. boat, then told them about it later.

Joe's recipe for a long healthy life was to keep busy and not give into old age. He spent his 90th birthday putting the finishing touches to a boat

he was varnishing on the shore of Charleston Lake, a short distance from his home overlooking the lake.

By his 90th birthday Joe Kelsey's hearing had failed considerably, about his only acknowledgement to old age. But he still had a remarkable memory and recalled the village as it used to be in the old days when there were lots of Indians around and when main businesses were a tannery and three hotels. He loved to tell the story about how the



Joseph (Joe) Kelsey



boys in the village went barefoot all the time and if anyone had to go to town, whoever it was would wear the one pair of boots that belonged to the crowd.

Joe Kelsey passed away on Saturday, January 6, 1962 at his residence overlooking the lake. His son Bill, age 88, still resides in Charleston Village and until he retired, was both a fishing guide and a contractor. Bill is now Charleston's Grand Old Man.

He still takes an active interest in the lake and frequently at the local restaurant recalls tales of days gone by. Joe Kelsey's grandsons, and Bill's sons Dwight, Roger and Wayne, reside in the vicinity of Charleston Lake and are well known members of the business community.

2004 Water Quality Survey Results

A water quality survey was undertaken on Charleston Lake during the period May 16th to October 25th. 2004, inclusive. The survey included six sample dates spread evenly over this period and included the sampling of seven (7) main lake basin locations according to the sampling protocol established by the Ministry of the Environment Lake Partner Program. Sample analysis was provided courtesy of the Ministry of the Environment.

The main lake basin sites included Big Water, Deep Water, Donaldson Bay, Eastern Water, Goose Island (North side, Charleston Harbour), Southern Water, and Webster Bay. The sample locations matched those sampled in previous years for the Ministry of Environment Lake Partner Program (LPP).

The total phosphorus level (TP) for the lake as a whole is a mean value of 13.219 ug/ L for 2004; this is a slightly higher mean value than reported for the year 2003. The whole lake mean TP value for all five years combined (2000 to 2004 inclusive) remains unchanged at 14.280 ug/L.

When comparing results for individual lake basins, the lowest mean phosphorus for 2004 is 12.343 ug/L recorded for Eastern Water while the highest mean value of 14.485 ug/L is reported for Webster Bay.

The 2004 water quality report and the full historical water quality test results are available at the associations' office for inspection.

Report to the Charleston Lake Association

Thank you to everyone who supported the Club 100 and who made other donations to the Charleston Lake Environmental Association in 2004. Your donations went a long way toward our being able to continue the work necessary to keep Charleston Lake beautiful in every way. Receipts were issued for all donations and we would like to remind you that the need for funds in 2005 is still pressing.

During 2004, \$39,000.00 was spent on those projects which were financed in part by the **Ontario Trillium** Foundation. The Charles-

ton Lake Association 'Pavilion in the Park' project has been completed, paid for and turned over to the United Counties of Leeds and Grenville. The Environmental Association acted as an intermediary so that tax receipts could be issued for donations to this project.

One half of the amount committed to the Leeds Stewardship Council has been paid in 2003 and 2004 to assist them with their 'Stream Rehabilitation' program. We have, still remaining, a commit-

ment of \$20,000.00 through 2006 on this vital project designed to inhibit the impingement of cattle and restore the ribbon of life planting along the stream and creek banks leading into Charleston Lake.

We will have important new news later this year about your Information Centre on County Rd. 40 which C.L.E.A. shares with C.L.A.. During the summer of 2004 Ms. Amy Gaines acted very capably as the Centre Manager. We and C.L.A. were helped by a Student Grant from the Federal Government H.R.D.C. to assist with her wages. We trust that we will be able to employ someone as truly capable as she in 2005.

The Directors of the Charleston Lake Environmental Association wish to thank you for your support in the past and encourage your continued support into the future.

Healthy Shoreline Review - Summer, 2005

2005 will be the fourth and final year of the Healthy Shoreline Review at Charleston Lake. The program is a part of the study of the lake, to determine the state of its health and its capacity to support development, recognizing its status supporting a population of lake trout. The reviews look at each property from the waterfront, noting the type and quantity of development, the types of natural habitat both above and below the shore edge, and the amount of natural shoreline present. A healthy forest and ground cover of vegetation absorbs and filters nutrient and sediment, retains and cools soil moisture, and cools runoff before it reaches the water, contributing to the overall health of the lake.

The field work part of the review is simply an information gathering exercise: there is no opinion about the type of property development. Using the information, a write-up is done for each property individually, with recommendations to the owner of how improvements might be made to the shoreline, to improve water quality of the lake, and aid the protection of natural habitats for wildlife of the region. The reviews are a snapshot of the state of development on the lake today, which can be duplicated in the future to monitor the direction of change. The reviews can help the Charleston Lake Association find ways to work with landowners to improve the quality of water and wildlife, the scenic views, and the quality of your experience at the lake.

So far, there have been nearly 500 properties reviewed, leaving about 300 to 350 to be done this summer. In 2002 – 2003, the northwest area of

the lake, from Donaldson Bay to around Slack's Point was done. This past summer, the area from Slack's Point, through Foster's Charleston Village to the area of Lookout Point was covered b y Hollingsworth and Melissa Warren. The remainder, including Provincial Park properties, will be done this coming summer. The 2003 reports were available at the CLA office or distributed except for a few with address glitches - last summer. The 2004 reviews have been written up this winter, and will be available in the spring at the CLA office. The 2005 reviews will be written up over next winter, and available the following spring.

Each review identifies the property through its assessment roll number and civic address. The owner is not identified by name. Only one copy of the review is printed, and is available only to the landowner. The review is presented in a binder, accompanied with a 72 page healthy shoreline stewardship manual which contains information on nearly 30 topics relevant to waterfront living, written specifically for this region.

Many individuals and groups have contributed to completing these reviews - in what is apparently the most ambitious project of its type in the country. When these reports have been completed, prepared by the Biosphere Network, the support and assistance of the Charleston Lake Association, the Charleston Lake Environmental Association, the Canadian Thousand Islands Heritage Conservancy, the Leeds County Stewardship Council,

Eastern Ontario Model Forest, the Environment Canada Habitat Stewardship Program, the Friends of Charleston Lake Provincial

Park, and the Shell Environmental Fund will all have been involved.

MESSAGE TO THE PRESIDENT

It was always our dream to be able to have a waterfront property, so summertime found us exploring every body of water in the region. Six years ago we were blessed to be able to purchase a home on Charleston Lake.

Charleston became the lake of choice for us because it is clean and deep, with a beautiful, rugged Canadian Shield landscape yet it is close to the Village of Athens and all the amenities of life. We also enjoyed the fact that Charleston is not a particularly busy lake yet it is busy enough, as people enjoy not only the boating opportunities but also the trails, picnic sites, beaches, and camping areas.

Because of our love for Charleston Lake we are concerned that its beauty and cleanliness continue on for many more generations. I would like to see the Lake Association come up with a program to assist landowners with inspecting and upgrading outdated and substandard septic systems. I believe that people are afraid to deal with this issue because they feel that the moment they ask questions about their system they will be forced into a complete retrofit with no financing options. Could the Lake Association arrange low interest loans for the purpose of septic system upgrades and repairs?
